Minutes February 28, 2017

The City of Langdon Place held its regular monthly meeting at the John Knox Presbyterian Church. Mayor Frank called the meeting to order at 7:00 p.m.

Present at the meeting: Mayor Mike Frank, Commissioners Kathleen Snyder, Charlie O'Bryan, Aaron Hardy, Attorney Stan Chauvin III and City clerk/Treasurer Theresa O'Bryan.

The minutes from the January meeting were read. Council member O'Bryan made a motion to accept the minutes as read. Council member Hardy seconded it. It passed in favor of accepting the minutes 4/0.

Old Business: It was reported that the View organization now has over 400 signatures for their petition to have the rezoning meeting at a sight in the east end of Louisville at an evening time. The attorney is Kevin Smith.

Attorney Chauvin had sent a letter out about the box truck parking on Blossom Lane. Attorney Chauvin said the City may want to amend the truck and trailer ordinance to better suit the needs of the city.

Chauvin said he may ask for a meeting with Candie Atkinson to see where the city is on the annexation revisal.

New Business: The Phase II of the tree planting will begin in the next few weeks. A list of the tree types and addresses was presented to the council. There was concern about how snow plowing would affect the newly planted trees if the city were to have a winter snow storm.

Mayor Frank suggested that the city wide yard sale be scheduled for May 20th and the Junk Day pickups be on Friday May 26th and Oct. 27th. The council wanted to get larger yard sale signs made in order to attract more attention.

Council member Hardy left messages with several leaf removal companies to get quotes. He hopes to have more information available at the next meeting.

Finance Report: The monthly bill report was presented to the council for review. Council member Snyder made a motion to approve the bills and Council member Hardy seconded it. It passed 4/0 in favor.

Beautification Report: Lawco is revising the quote for the maintenance of the entrances way grounds. It was suggested to eliminate the mulching from that contract. The council felt that it is in the best interest of the city to have the arborist (Kristin Booker) to work closely with the company chosen to mulch the trees. She does not recommend volcano mulching as was done in the past.

Council member O'Bryan has decided on the correct specs for the painting of the mailboxes. He will inform the residents that will be getting new mailbox units know before the process of replacing begins.
